- Following discussion of concerns, proposed text for PC objection read and generally approved with some amendments needed. Agreed to demand OCC require a full environmental impact assessment to reduce standoff to less than 350 M; that at least five properties are within the applicant's proposed 200 M; that residents are concerned about the accuracy of the sites from which the applicant's maps show where measurements were conducted from; to emphasize the potential health risks to children using the school playing field.
